#### Notice of amendment to criteria for 2012 and future lists:-

At the Joint meeting of all 7 UK Border Terrier Clubs on 1 May 2010, the Clubs agreed that the requirements for people to have passed the following assessments will apply to NEW APPLICANTS to the 2012 B List for Breed Specialists as well as to A3 list Breed Specialist applicants. From the 2013 lists, it will apply to ALL applicants to the Breed Specialists' B lists and A3 lists.

- To have attended a seminar given by a Kennel Club Accredited Trainer, and passed the relevant examination on the Kennel Club Regulations and Judging Procedures.
- To have attended a seminar given by a Kennel Club Accredited Trainer on Conformation and Movement (currently K.C. Policy for A3 list Breed Specialist applicants).
- To have attended a seminar given by a Kennel Club Accredited Trainer and passed the "Hands on" assessment of judges' knowledge of Conformation and Movement, covering Points of the Dog, The Structure of the Dog and The Conventional Measurements of the Dog

#### Overseas judges:

At the Joint meeting of all 7 UK Border Terrier Clubs on 6 May 2012, it was agreed that the following wording would be added to the base of the A3 Breed Specialists and B Breed Specialists lists: "In the case of overseas judges, broadly similar criteria will apply."

# Notes for 2016 and later lists:

Re criteria (number of dogs judged): Since the 2015 lists were prepared, we have now, for the 2016 and later lists, amended our A3 criteria for both Breed Specialists and Non-Breed Specialists regarding the number of dogs judged to be in accordance with the Kennel Club requirements for our Stud Book Band; see our website at the following web address and also the criteria as shown above the A3 lists on the previous pages: http://www.theborderterrierclub.co.uk/judgescriteria.html

# <u>Judges selection: advance notice regarding Observed judging appointments under</u> the Kennel Club's Judges Competency Framework:

A discussion took place at the Joint Border Terrier Clubs' meeting on 6 May 2018 concerning a Border Terrier Club proposal regarding the number of dogs that a prospective judge should have judged before being "Observed" in accordance with the Judges Competency Framework. 'Observations' can only take place at either

- 1. a breed club show,
- 2. a supported entry show or in

3. non-cc classes at a championship show (which for our breed is only Belfast).

Those present at the meeting agreed that before anyone was put forward to judge at either a club show or a club supported entry show and be observed, they must have first judged at least fifty Border Terriers.

# Advance notice to judges re changes for 2019 onwards re Judges Competency Framework:

**PLEASE NOTE:** the criteria for all our Judges' Lists, as currently shown under each heading above, will continue to apply up to and including 2021, apart from our **C list which will be extinct from 2020** (not 2019 as per the Judges Competency Framework Booklet which came out in March 2018 at Crufts but which has since been superseded by instructions from the Kennel Club in April 2018).

Under the current rules/guidelines from the Kennel Club (though we need to watch for any subsequent changes after these lists have been prepared):

**For the transitional years 2019 to 2021 inclusive,** judges may be invited to judge shows **either** if they are on the relevant level of the Kennel Club Academy ("KCA"), **OR** if they are on a Breed Club Judges' List.

However, we have since been advised that the KCA will now not be up and running until the 2nd half of 2019, so the Breed Education Co-ordinator will hold the details you would have entered onto the KC Academy website, on her Workbook until the system goes live.

## For example:

You may be invited to judge a Breed Club Open show for 2020 and 2021 if you are on the KCA Level 2 or above, **OR** if you are on the Breed Club's B List at the time of the invite.

You may be invited to judge a Championship show for 2020 and 2021 if you are on the KCA Level 4 **OR** if you are on a Breed Club's A1 list at the time of the invite (AND in the case of Breed Club Championship shows, have judged the breed at CC level the relevant number of times as per each Club's Rules).

From 2022 onwards, <u>under the present rules/guidelines emanating from the Kennel Club</u>, you may only accept judging appointments and carry out those appointments if you are (or will be at the time of the appointment) a paid up member of the Kennel Club Academy. For years prior to 2022, invites may be accepted as per previous rules. HOWEVER, THE JCF IS CURRENTLY ON HOLD, AS AT OCTOBER 2019, SO PREVIOUS RULES APPLY NOW.
